Fax Order Form "dena-Subsidy Overview EU-27"

The following incidental provisions apply:

Payment Terms

The agreed fee shall be due after receipt of an invoice from dena.

Right of Termination by dena

dena shall be entitled to terminate the contract at any time with a notice period of 4 weeks to the end of the month. Notice of termination must be given in writing. In the case of termination only the services provided by dena to date will be payable.

Miscellaneous

Amendments and additions to this contract must be made in writing. No verbal agreements have been made subsidiary to this contract.

Should any provision of this Contract be or become invalid the validity of the remaining provisions shall not be affected. The invalid provision shall be substituted by a legally valid provision which most closely approximates to the economic intent of the Contract parties. The same shall apply to any contractual loopholes.

Any legal disputes arising from this Contract shall be referred to the regional court of Berlin.

This contract is governed by and construed in accordance with the laws of the Federal Republic of Germany under exclusion of German private international law and the UN Sales Convention.

This translation is provided for information purposes only. The German version is applicable.

Consequences of Revocation

In the case of effective revocation, the services received by both parties and any benefits from such services (e.g. interest) shall be returned. If you are unable to return to us in whole or in part the goods received or if such goods can only be returned in a state of deterioration, you may be liable to pay compensation. This shall not be the case if such deterioration is solely the result of an examination of the goods such as would have been possible in an in-store examination. You may otherwise avoid the liability to compensate for any deterioration in value by not taking the goods into use and by avoiding anything which impairs their value.

Printed matter which can be returned as a parcel should be returned. You are liable for the return expenses if the goods delivered are those ordered and if the price of the returned goods is not greater than € 40 or, where the price of the goods is higher at the time of revocation, you have not paid for the goods or you have not made a contractually agreed part payment. Otherwise you may return the goods free of charge.

Information on Distribution and Reproduction Ban

Considerable investment was involved in researching the contents of the brochures and they are updated on a continuous basis. They are provided to the user for internal use only. The contents of the brochures may not be sold or distributed. The purchaser agrees with the following regulation in respect of compliance with the aforementioned distribution and reproduction ban:

The distribution or publication in written or electronic form of information from dena-Subsidy Overview EU-27 is subject to prior written agreement by dena. In such cases dena shall be named as the source.

"Information" means any content including pictures and tables from the dena-Subsidy Overview EU-27.

The confidentiality undertaking is not valid for information which

- relates to state-of-the-art technology accessible to the general public at the time of receipt or thereafter;
- was already known to the Purchaser when the information was received;
- is provided to the Purchaser by an authorized third party;
- If the Purchaser shall invoke one of the aforementioned exemptions he shall be liable to furnish proof thereof.

Any violation of this provision shall be subject to a penalty of € 5.000.

The ban on distribution and reproduction of the information acquired shall end one year after receipt by the Purchaser of the current version or update of dena-Subsidy Overview EU-27.
