


3rd German-Polish Energy Transition Forum

A Strong Partnership for Europe's Energy Security



On **3 December 2025**, the **3rd German-Polish Energy Transition Forum** will take place in Warsaw. The event is organised within the framework of the German-Polish Energy Plattform.

The German-Polish Energy Platform is implemented on behalf of the Federal Foreign Office by the German Energy Agency (dena) in cooperation with the Polish National Energy Conservation Agency (KAPE). The forum takes place in partnership with the Polish-German Chamber of Industry and Commerce (AHK Poland) and the Embassy of the Federal Republic of Germany in Poland.

The forum provides a platform for political, economic, and societal stakeholders involved in the energy transition in Germany and Poland to exchange ideas and network. It will address the following topics:

- Power grids as the key to the energy transition: How can the transformation of the energy system be achieved?
- EU Clean Industrial Deal: decarbonisation of industry as an opportunity for Europe's competitiveness.
- How can Europe achieve energy security and protect critical offshore infrastructure?

The event will take place in person and will be **simultaneously translated** into German and Polish.
